1. Discuss, review, and consider any action related to infrastructure and additional damage as a result of severe winter weather.

Mayor  $\rightarrow$  gives summary of weather storm that caused power outages due to ice on power lines and trees. City called in back-up crew to assist with restoring power due to a concern for the life and safety of the residents. Electric crew worked through the night to restore power as safe and quickly as possible. Worked 16-12 hours days throughout the duration of the severe winter weather. Damage equivalent to tornado/extremely high winds. Crew ran new wires, transformers, fuses, tree trimming and a number of other needed repairs. Praises community efforts and kindness during this emergency.

### MPT Roome $\rightarrow$ discussed the possibility of other contractors outside of the one used during the winter storm.

#### City Administrator →

- Short Term (Days): Fix remaining issues uncovered by snow/ice melt → water and wastewater lines, tree debris, delayed work from previous week.
- Mid-Term (~2-3 weeks): Explore emergency management plan to better prepare for future disasters.
- Long-Term (~4-6 weeks): Assess extent of emergency expenditures as the city replaces materials used. Will seek all opportunities for reimbursement.

#### No action taken.

2. Discuss, review, and consider any action regarding internet protocols and the posting of official City of Bartlett information on Facebook and other social media sites.

#### MPT Roome $\rightarrow$ Request the city ensure the use of proper channels of communication to prevent potential violations of law.

MPT Roome → Makes a motion to direct City Administrator to review existing social media policy for improvements and report to City Council at the next meeting.

No second, Motion fails.

3. Discuss and review historical charges for electrical maintenance and contractor charges in 2020-2021.

#### MPT Roome → 2020 calendar year expenditures for electric contract services ~\$180,000

MPT Roome  $\rightarrow$  2020 rates are non-comparable to rate charged for emergency expenditures

Mayor  $\rightarrow$  The City of Bartlett should have discussed contract with emergency electric contractor (Billy Hohensee) in the months and years prior to recent severe winter weather.

Mayor  $\rightarrow$  However, Billy has proved reliable compared to other vendors

Mayor  $\rightarrow$  City needs to go to bid for electric services

Mayor → Techline proved unreliable in response time and inappropriate response measures related to crew and vehicles

#### CM Romero $\rightarrow$ Makes a motion to table agenda items #4, 5, and 6 to a meeting discussing an Emergency Management workshop. CM Cooper $\rightarrow$ Seconds motion. Motion passes 5-0

4. Discuss, review, and consider any action related to setting maximum amounts of allowable pay for outside contractor services on a dollar per hour basis.





  - Pursue legal action against ERCOT and/or challenge existing LCRA contract
- Considerations
  - LCRA invoice will continue to accrue interest
  - Legal fees are open-ended



# **UNKNOWN - Grant Funds**

- Received Recent Federal Stimulus and FEMA Funds
  - Stimulus Funds Allocated for City
  - FEMA Reimbursement
- Considerations
  - Are energy costs eligible expenditures?
  - Will all current storm expenditures be reimbursed?



# **UNKNOWN - Legislative Action**

- Texas Legislature
  - Currently investigating ERCOT and fact finding
- Considerations
  - Highly unlikely considerable action will be taken




