#### **RESOLUTION NO. 20231120-01**

#### RESOLUTION CANVASSING ELECTION RETURNS OF BOND ELECTION

WHEREAS, the City Council of the City of Bartlett, Texas (the "City") ordered an election to be held in the City on November 7, 2023, on the PROPOSITION hereinafter stated; and

WHEREAS, the City Council has investigated all matters pertaining to the election, including the ordering, giving notice, officers, holding, and making returns of the election; and

**WHEREAS**, the election officers who held the election have duly made the returns of the result thereof, and the returns have been duly delivered to this City Council.

# THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BARTLETT, TEXAS:

- 1. The City Council officially finds and determines that the election was duly ordered, that proper notice of the election was duly given, that proper election officers were duly appointed prior to the election, that the election was duly held, that the City has complied with the Federal Voting Rights Act and the Texas Election Code, that due returns of the result of the election have been made and delivered, and that the City Council has duly canvassed the returns, all in accordance with law and the Resolution calling the election.
- 2. The City Council officially finds and determines that the following votes were cast at the election on the submitted PROPOSITION by the resident, qualified electors of said City, who voted at said election.

#### **PROPOSITION A**

TERMINATION OF THE BARTLETT ECONOMIC DEVELOPMENT CORPORATION (TYPE B) AND ITS ASSOCIATED SALES TAX; AND THE ADOPTION OF A LOCAL SALES AND USE TAX IN THE CITY OF BARTLETT AT A RATE OF ONE-HALF OF ONE PERCENT. THIS WOULD RESULT IN NO CHANGE IN THE TOTAL SALES TAX RATE.
