## NOTICE OF MEETING TO VOTE ON TAX RATE

A tax rate of \$0.554900 per \$100 valuation has been proposed by the governing body of the City of Bartlett.

The no-new-revenue tax rate is the tax rate for the 2022 tax year that will raise the same amount of property tax revenue for City of Bartlett from the same properties in both the 2021 tax year and the 2022 tax year.

The voter-approval tax rate is the highest tax rate that City of Bartlett may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is not greater than the no-new-revenue tax rate. This means that City of Bartlett is not proposing to increase property taxes for the 2022 tax year.

A PUBLIC MEETING TO VOTE ON THE PROPOSED TAX RATE WILL BE HELD ON September 12, 7:20 PM 2022, at City Hall located at 140 W Clark Street, Bartlett, TX 76511.

The proposed tax rate is also not greater than the voter-approval tax rate. As a result, City of Bartlett is not required to hold an election to seek voter approval of the rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the City Council of City of Bartlett at their offices or by attending the public meeting mentioned above.

The following table compares the taxes imposed on the average residence homestead by City of Bartlett last year to the taxes proposed to be imposed on the average residence homestead by City of Bartlett this year:
