Dear Ms. Cantu,

In 2004 Williamson County was identified as an Urban County Entitlement for the Community Development Block Grant Program through the U.S. Department of Housing and Urban Development (HUD). Since then, the County has received a yearly CDBG allocation and has been able to fund projects that assist low income individuals and households throughout the County.

In accordance with HUD regulations, this letter is an essential component to assure Williamson County meets the HUD Urban County program eligibility requirements for population and program guidelines. More specifically, it is through our County's combined population numbers that this opportunity is possible. Hence, the program promotes the cooperation and collaboration between all Williamson County citizens in urban and rural areas. Your participation is vital to improving all communities within Williamson County.

Your participation does not prohibit your city from applying for other State HOME funds and provides the opportunity of formula allocations in the HOME Investment Partnership Program. As long as the County remains listed as an eligible Urban County as defined by HUD, this grant can be a renewable and ongoing opportunity.

Your city is currently not participating in the Williamson County CDBG program. We would like to encourage your participation. If Bartlett elects to participate, please complete the enclosed level of participation form indicating "agrees to participate". The document should be mailed to the Williamson County Community Development office at 710 Main Street, Georgetown TX 78626, or emailed to sbardwell@wilco.org. The document must be received by June 28, 2024 in order to participate.

If, however, Bartlett wishes to be excluded from this program and no response is received by June 28, 2024, Bartlett will forfeit its opportunity to take part in the Williamson County CDBG program until the next available requalification period.
